OFF-LICENCE

Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **<u>RIPPON VINEYARD AND WINERY LIMITED</u>** is authorised to sell and supply alcohol on the premises situated at **246 Mount Aspiring Road**, **Wanaka** and known as **"The Rippon Hall"** to any person for consumption off the premises, and to supply alcohol free, as a sample, for consumption on the premises.

This licence is not endorsed under section 40 of the Act, and the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- a) No alcohol is to be sold or delivered on Good Friday, Christmas Day or before 1.00pm on Anzac Day.
- b) No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made:
 - i) on the premises; or
 - ii) from grapes or fruit harvested from land on which the premises are situated.
- c) Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday 9.00 am to 8.00 pm

- d) The cellar door tasting room is designated **supervised**, with the remainder of the premises undesignated, in accordance with the plan of the premises submitted to the District Licensing Committee on 14 January 2021.
- e) According to the Sale and Supply of Alcohol (Fees) Regulations 2013 the premises is assigned the fees category: **Very Low Winery Cellar Door**.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force –

- a) Either
 - i) Until the close of the period for which it was last renewed; or
 - ii) If it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- b) If an application for the renewal of the licence is duly made before the licence would otherwise expire, either
 - i) Until the close of the period of 3 years after the period for which it was last renewed; or
 - ii) If it has never been renewed, until the close of the period of 4 years after the day it was issued.
