Off Licence

Issued under Sections 17 to 20, and 64 of the Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 The Bluff Distillery Limited is authorised to sell alcohol, on the premises situated at **250 Ocean Beach Road**, Bluff and known as **BLUFF DISTILLERY** to any person for consumption off the premises, and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed, under Section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the Licensee in accordance with Part 2 Subpart 7 of the Act.

Conditions:

- (a) Alcohol may be sold only on the following days and during the following hours:
 - Monday to Sunday from 10.00am to 8.00pm
- (b) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on ANZAC Day.
- (c) Each of the following parts of the premises is designated as a supervised area: The bottle store and tasting area.
- (d) When alcohol is being supplied free as a sample on the premises, potable drinking water must be freely available from filled jugs with glasses stationed on the main counter.
- (e) The licensee must implement and maintain the steps proposed in the application for the licence including the Host Responsibility Policy aimed at promoting the responsible consumption of alcohol.
- (f) The licensee must ensure the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.

The Licensed Premises

The Premises located at 250 Ocean Beach, Bluff are more precisely identified as outlined in the plan received by the Invercargill District Licensing Committee on 6 January 2025.

Display of Licence and Principal Entrance

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from Ocean Beach Road, Bluff is designated as the principal entrance.

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

(a) either—

- (i) until the close of the period for which it was last renewed; or
- (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
 - (i) until the close of the period of 3 years after the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, the licence expires on:
